2. Queries – The life of the Meeting depends upon varied gifts.

  - Stuart summarized the history of ICJ. Bill Greenleaf of was one of the founders during a local period of high racial conflict. An influential group in times of difficulty, and a worthwhile group in which Friends can interact with interfaith leadership on a first name basis. Meeting has several times sought to add death penalty opposition to ICJ's agenda. Meets five times a year, usually Mondays from 10 noon.
  - <u>Minuted (2012.9)</u>: Meeting approved Mike Shell as the new representative. Stuart will advise him when the next meeting is scheduled and introduce him at that meeting.

  - Bonnie attended SEYM's Fall Interim Business Meeting on 10/6/2012.

- <u>Wendy Clarissa Geiger</u>
  - Letter of intent, dated 9/7/2012, read into minutes (Attachment 3)
  - Clearness Committee (Elaine Martin, Phoebe and Neil Anderson of Tallahassee Meeting, and Cheryl Demers of Gainesville Meeting) met with Bonnie Wendy on 9/22/2012.
  - The Committee minuted that Meeting accept Wendy into membership, and the Clerk read the minute to Meeting (Attachment 4).

**6. Meeting Location** – Consideration of Brooke Stephens' home at 2013 Rowe Ave., Jacksonville, FL 32208

- On 9/9/2012, Meeting agreed that we are favorable toward this move but will defer a decision until next meeting for business while some concerns are addressed.
- Some concerns remain, and Meeting asked that the Clerk and Treasurer confer with Brooke about these issues, as well as seeking clarity about her overall expectations, before proceeding. The First Day School effort awaits a decision, since Brooke's home would provide adequate space for it.
  - <u>Backdoor lock</u>: Bonnie and Kenneth Hall think the back sliding glass door might accommodate Bonnie's chair, but Brooke no longer has a key. She has asked that Meeting pay her regular locksmith to change the lock. Meeting will ask for an estimate before acting.
  - <u>Parking</u>: Friends are concerned about accessible parking. The back concrete area and side yard flood, and this may prevent van/wheelchair access and has already caused some cars to be stuck.
  - <u>Liability insurance</u>: The Treasurer will investigate the potential for conflicting claims between the Meeting's insurer and Brooke's.
  - <u>Future use of Evergreen location</u>: If Meeting leaves Evergreen Cemetery and later needs a space, we want to know if they will welcome us back.
