2. Oueries

- <u>Discussion</u>: Friends shared examples of joy-filled experience.
 - One Friend described how the hymn "O come, O come, Emmanuel" reminds her of the "expectant waiting" which is part of Quaker worship
 - o Another spoke about the Buddhist nun Pema Chödrön's paradoxical teaching that joy comes in accepting that we are "never going to get it all together."
 - o Another recalled previous Meeting experiences of canoe trips and proposed that we consider doing one again.
 - Note: Friends agreed that this proposal should be a future agenda item.

4. Treasurer's Report – Sue Watson

- Current balance is \$2,295.52.
- Pending expenditures include two quarterly SEYM apportionment payments.
- <u>Minuted (2012.14)</u>: Friends agree to a maximum \$100 expenditure for a Christmas gift for employees of Evergreen Cemetery.

5. Membership

- <u>Minuted (2012.15)</u>: Friends approve the November 3, 2012, Minute Recommending Membership for Bonnie Hall.
- Celebration Party for New Members: Friends agreed to a celebration potluck, hosted at the Clerk's home in January or February (possibly 2/3/2013).
- Membership Committee: Friends gave careful consideration to SEYM directory changes due January 31st and to both the "core" and "extended" versions of the Meeting's email list.

- **6. Spiritual State of the Meeting Statement** The Recording Clerk distributed copies of the 2011 Statement, together with queries proposed by SEYM Ministry and Worship Committee.
 - The 2012 statement is due to SEYM by January 25th.
 - Friends targeted the second week of January for a worship sharing and discussion.
 - Mike agreed to check with the Southeast and South Mandarin branches of Jacksonville Public Library for possible evening meeting space.

7. First Day School

- Friends agreed that Meeting wants to honor our children, and that the main problem is one of logistics, not intention.
- Bess Wilson proposed that we separate the issue of Meeting location from that of First Day School, and that we start having twice monthly First Day School events during Meeting for Worship.
- Minuted (2012.16): Friends approve beginning First Day School in January, on the first and third First Day of each month, with one of those days including intergenerational activities.

- Friends agreed that there is still not unity about moving Meeting to Brooke's home and agreed to hold the matter over until next meeting for business.
- Evergreen Cemetery may be willing to let Meeting use its chapel. The Clerk will investigate.
