 - o Meeting agreed to invite Palm Coast and Gainesville, and Elaine will investigate
- October 20th will be the first occasion for 3rd First Day Potluck following worship
- Discussion, Adult First Day School and similar options
 - Meeting expressed general interest and considered various time options: after potluck, on a Friday night, etc.
 - o A Friend proposed having planned topics but not a series
 - o Agenda item for October Friends should consider the issue and give feedback
- Nancy Fennell workshop on deepening spirituality
 - SEYM has a number of traveling ministers able to do workshops and presentations for YM meetings (see http://www.seym.org/Workshops.html)
 - o Agenda item for October Friends asked for a written description of this option.

6. One Campaign (Attachment)

- An international organization campaigning to end extreme poverty
- Advocacy only, not fundraising, for issues such as agricultural development, global health and ending energy poverty (especially in Africa)
- Mike will investigate.

7. Tampa Friends – 9/3/13 Minute Regarding Syrian Conflict

- Text" "The violence and deaths in the Syrian civil war grieve the Tampa Meeting of the Religious Society of Friends (Quakers), and we think the international community should respond. However, military strikes would only bring more violence and death to Syria. We ask for a political solution that relies on enhanced diplomacy, restricted flow of weapons to all parties in Syria, investigation of war crimes, and increased humanitarian aid. Military intervention will bring more violence to a region that needs a commitment to peace."
- Minuted (2013.9) Jacksonville Meeting supports the Tampa minute.

8. Housekeeping

- Interfaith Council Mike has had not notices of meetings since February. He will investigate.
- Website Ken Hall now has the passwords and has updated the Meeting address
 - o Administrative/financial/technical issues
 - Site is registered in Heidi Lowey-Ball's name, and she paid \$13/month in advance to the end of 2014
 - Current Domain Name System (DNS) registrant charges \$35/year, but GoDaddy would charge only \$8/year

Hello,

My name is Marisa Vertrees, and I am the Faith Mobilization Manager for the ONE Campaign. ONE is an international organization that advocates for an end to extreme poverty, and works to build awareness and support for agricultural development, global health, and other programs that help the poorest of the poor around the world. We are not a fundraising organization, and only work on advocacy and education. We're not asking for your money--just your voice. I am writing because I was hoping to speak with someone from the Jacksonville Meeting of Friends. ONE currently works with a number of national partners, including faith based partners such as CRS, Bread for the World, Episcopal Relief and Development, and American Jewish World Services. We are currently trying to work more closely with local faith leaders and partners to build support for global development, and amplify the voices of people of faith. We are currently running a campaign to end energy poverty, beginning with support for a bill to expand access to electricity on the African continent.

I have attached some information about our current campaign, but I would appreciate the opportunity to speak with you further about ONE, as well as our energy campaign. We are currently asking local leaders to support this campaign, and to write to their representative asking him or her to co-sponsor the Electrify Africa bill. I have also attached a sample letter, although we are glad to work with you to craft your own letter as well.
