7. **FIBM update**- Elaine Martin

Elaine gave a report from the SEYM Fall Interim Business Meeting which was held in Palm Beach on October 5<sup>th</sup>, 2013, which included:

- SEYM Youth Program – Elaine read the report which was presented at FIBM. The report details the youth's year-long activities supporting the Immokalee Workers Campaign for fair food.

- Circus McGurkis – A People Fair dedicated to celebrating peace education, sponsored by St. Petersburg MM is scheduled for October 26 Meeting discussed the activities and history of the fair.
- There are positions open in SEYM for anyone interested in serving at the yearly meeting level.
- Pendle Hill Scholarship of \$200 is still available.
- A SEYM Peace and Social Concerns list of initiatives under consideration includes: the death penalty, mass incarceration, water, bees, military spending, and Quaker House.
- Collaboration between meetings working on shared interests was discussed and highly encouraged.
- Earthcare Committee – The minute for climate change is still under discernment.
- Elaine announced that Susan Taylor, Tallahassee MM, was invited to assist the Independent Worship Group of Greater Boston in their discernment concerning their relationship with FUM in light of their policy on homosexuality. Susan was the YM clerk at the time SEYM was discerning our relationship with FUM.
- SEYM 50<sup>th</sup> Anniversary – It was announced that this year SEYM will be celebrating their 50<sup>th</sup> anniversary during the yearly meeting gathering. Anyone who has ideas for the celebration is encouraged to contact YM gathering committee.

8. **Meeting Housekeeping** -All items held over for next business meeting.

Dear Members and Attenders of Jacksonville Friends Meeting,

Each year Southeastern Yearly Meeting (SEYM) contacts each Monthly Meeting and Worship Group as part of its annual planning cycle. Representatives from SEYM inquire about the status of members and attenders affiliated with Jacksonville Meeting and do the same for other Meetings and Worship Groups. Members of our Meeting then contact our list of members and attenders to determine their interest in maintaining a relationship with our Meeting.

Those involved in the SEYM budget process calculate the percentage of total Yearly Meeting membership represented by our Meeting members/attenders, and apportion that percentage of SEYM's Annual Budget to our Meeting. For the fiscal year June 1, 2013 through May 31, 2014 Jacksonville Friends Meeting was requested to contribute \$2,518 to SEYM as our apportionment. The math works out to approximately \$119 for each of our 10 members and \$60 for each of our attenders. In addition to the Meeting's apportionment there are ongoing expenses of the Meeting for rent, insurance, contributions to local charities, subscriptions, etc. As a Meeting we have also decided to set aside funds with the goal of being able purchase a permanent place to hold Meeting for Worship and First Day School.

All contributions to the Meeting are deeply appreciated. Only you can examine your personal circumstances to determine what would be appropriate. We hope that you consider our Meeting to be among your highest charitable priorities and that you make a gift that you feel is significant. Donations need not be in the form of a single gift.
