**2018.01.21-2** – Jacksonville Friends accept Wendy Clarissa Geiger's decision to set aside both her long-time role as newsletter editor and her newly assumed role as recording clerk. We love her messages and writing and look forward to her continued contributions.

#### ICARE updates and meetings - January 19, 2018

**Mini Action with the Sheriff -Tuesday January 23rd** at Greater Grant AME located at 5533 Gilchrist Road. The pre-meeting is at 12:30.

We need at least 50-100 people in this meeting. Last year, the Sheriff's office lost \$600,000 that was meant to fund the Jacksonville Re-entry Center, a national model. We plan on asking Sheriff Williams to commit to making a plan to recoup JREC's budget back to \$1.5 million by 2019 and to present it to us at the Nehemiah Assembly on April 23rd.

#### **Policing Committee:**

To date, we have met with the State Attorney, The JSO Director of Corrections and The Vera Institute of Justice to collect data on the scope of the problem and best practices from other communities.

Notes from the three meetings are available from Mike Shell or Elaine Martin.

Some main points from the meeting with Vera Institute:

- 1. We should expect it to take up to 6 months to get data from the police.
- 2. Police focus on enforcement over service to the community has led to mistrust.
- 3. It is very difficult to prove racial profiling.
- 4. There are several national organizations that help train police departments and develop policies to make police practices more equitable. (listed in notes)
- 5. There are no models of accountability for police misconduct. Holding police officers accountable is still an elusive task in all parts of the country.
