## • Backups for opening & closing meetinghouse

- o The clerk has no reliable backup to open and close Meeting for Worship when he must be away.
- We ought not to continue cancelling worship in such cases, because we have visitors and returning newcomers almost every week.
- SEYM Fall Interim Business Meeting is October 6<sup>th</sup> in St. Petersburg <u>seymquakers.org/business-meeting</u> is October 6<sup>th</sup>, so October 7<sup>th</sup> is the next Sunday when we need someone to take do this.
- Sue Watson may be able to do so.
- Assistant treasurer Sue Watson's second 3-year term ends on December 31, 2019.
  - Meeting needs an assistant treasurer to be in training as Sue's.
- Recording clerk The clerk now doubles in this role and needs to lay it down.
  - This interferes with attending fully to clerking a worshipful decision-making process.
  - A recording clerk has two main responsibilities:
  - To take meeting for business notes & help the clerk draft recorded minutes

- Website manager/editor Now done by the clerk, who must lay down the role.
  - Basic maintenance of www.jacksonvillefriends.org
  - Keep Events calendar up to date www.jacksonvillefriends.org/events
  - The clerk changing the website back to a static rather than blog-based site.
  - A volunteer need not know coding. Our WordPress platform does most of the formatting, and the clerk can train a successor how to use it.
- **Newsletter editor** Now done by the clerk, who must lay down the role.
  - Meeting used to mail monthly printed newsletters with a calendar of events plus articles.
  - In January 2017 we switched to email distribution, except for a short list of Friends who need print
    copies mailed because they do not use email.
  - o However, the clerk has only had time to produce six issues since then.
