# Thanx for your faith and support

We had two intensely rewarding AVP workshops in Nicaragua. The seeds of peace and non-violence have been sown in a place both needy and ready. Nurturing has begun, in unexpected places. The leaders of the National Police, who started a volunteer organization (ANIPRED) to deal with juvenile delinquency in Nicaragua, are very excited about the potential of AVP to help families and youth in Nicaraguan communities. Healing the deadly devisiveness fomented by years of U.S.-inspired war is a great challenge.

I am grateful that I had the opportunity to represent SEYM in Nicaragua. I partook of so much there that moved me The efforts of those I met at reconciliation for a deeply. painfully divided, war-torn country, which is still being crippled by an economic war waged by our government, are humbling. The images of Nicaragua are strong for me children, smiling and beautiful; the landscape, alternately parched brown and splashed with exotic tropical color; the roads, filled with the dust and diesel fumes of every imaginable size and type of bus and truck, mostly filled beyond capacity like Kitty Madden's, in the bed of which I rode everywhere with people, suitcases, live chickens, bags, stalks of bananas, bottles of water, all being bounced around together on rocky curves, while we negotiated among ox carts, lean horses, sparer cattle, and incredibly skinny dogs, a few bicycles, and people, always people, with packages, under their arms, at their feet, balanced on their heads.

From Jenny, and Carmen, and Kitty and Pablo, and Jorge and Ileana, and all the others who will benefit from the experience of AVP in Nicaragua, and from me, who already has,
